

DIRECTIONS TO COWETA COUNTY JUSTICE CENTER

TRAVELING SOUTH ON I-85

**TAKE EXIT 41 MORELAND/GREENVILLE EXIT
BEAR RIGHT ONCE OFF THE EXIT RAMP (29 NORTH-TOWARD NEWNAN)
CONTINUE STRAIGHT TOWARD DOWNTOWN NEWNAN FROM THE
INTERSTATE FOR APPROXIMATELY 2.7 MILES WHERE YOU WILL COME TO
YOUR FIRST TRAFFIC LIGHT*(STREET MARKERS: SPENCE AVE.,)
PROCEED STRAIGHT THROUGH THE LIGHT AND ABOUT .6 MILES ON YOUR
RIGHT IS THE COWETA COUNTY JUSTICE CENTER. THE STATE COURT
CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100**

**YOU MAY TAKE EXIT 47 NEWNAN/SHENANDOAH EXIT AND PROCEED RIGHT
(WEST) ONTO BULLSBORO AND FOLLOW THE DIRECTIONS FOR TRAVELING
FROM SHARPSBURG, PEACHTREE CITY AND FAYETTEVILLE**

TRAVELING NORTH ON I-85

**EXIT 41 NEWNAN/MORELAND EXIT
TAKE A LEFT AT THE TRAFFIC LIGHT AT THE END OF THE EXIT RAMP AND
GO UNDER THE INTERSTATE (29 NORTH-TOWARD NEWNAN)
CONTINUE STRAIGHT TOWARD DOWNTOWN NEWNAN FROM THE
INTERSTATE FOR APPROXIMATELY 2.27 MILES WHERE YOU WILL COME TO
YOUR FIRST TRAFFIC LIGHT *(STREET MARKERS: SPENCE AVE.,)
PROCEED STRAIGHT THROUGH THE LIGHT AND ABOUT .6 MILES ON YOUR
RIGHT IS THE COWETA COUNTY JUSTICE CENTER. THE STATE COURT
CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100**

TRAVELING WEST ON 34 FROM SHARPSBURG, PEACHTREE CITY AND FAYETTEVILLE

**TRAVEL WEST ON 34 (BULLSBORO DRIVE) AND COME STRAIGHT TOWARD
NEWNAN. WHEN YOU GET TO THE WATER TOWER ON YOUR LEFT, MAKE
SURE YOU GET IN THE LEFT LANE AND REMAIN IN THE LEFT LANE. YOU
WILL COME TO A SET OF TRAFFIC LIGHTS NEAR A CEMETERY WHERE YOU
WILL HAVE TO BEAR TO THE LEFT ONTO JACKSON ST./US-29 S/GA-14/US-27
ALT S/GA-16 E/JEFFERSON MEMORIAL HWY.
TURN RIGHT ONTO US-29 S/GA-14 S/US-27 ALT S/GA-16/JEFFERSON DAVIS
MEMORIAL HWY. THE COWETA COUNTY JUSTICE CENTER WILL BE ON YOUR
LEFT. THE STATE COURT CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE

TRAVELING EAST ON 27 FROM CARROLLTON OR EAST 34 FROM FRANKLIN

TRAVEL EAST ON US 27 ALT/34 WHEN YOU REACH THE CITY OF NEWNAN,

CONTINUE WHERE US-27 ALT/34 RUN INTO TEMPLE AVE., CONTINUE STRAIGHT UNTIL YOU REACH JACKSON STREET, THEN TURN RIGHT ONTO JACKSON STREET/US-29 S/GA-14S/US-27 ALT SGA-16 E/JEFFERSON DAVIS MEMORIAL HWY CONTINUE TO FOLLOW US-29 S/GA-14 S/US- 27 ALT/GA-16 E/JEFFERSON DAVIS MEMORIAL HWY. THE COWETA COUNT JUSTICE CENTER WILL BE ON YOUR LEFT. THE STATE COURT CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100

TRAVELING SOUTH ON 29

TRAVEL SOUTH ON US-29 S/GA 14 AND COME STRAIGHT INTO DOWNTOWN NEWNAN, TURN RIGHT ONTO US-29/GA-14/GREENVILLE STREET/US-27 ALT/GA-16/JEFFERSON DAVIS MEMORIAL HWY. THE COWETA COUNTY JUSTICE CENTER WILL BE ON YOUR LEFT. THE STATE COURT CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100

TRAVELING NORTH ON 29

TRAVEL NORTH ON US-29/GA-14/US-27 ALT/JEFFERSON DAVIS MEMORIAL HWY TOWARD GA-16. CONTINUE STRAIGHT ON 29 NORTH TO DOWNTOWN NEWNAN FROM THE INTERSTATE FOR MARKER: SPENCE AVE.,) PROCEED STRAIGHT THROUGH THE LIGHT AND ABOUT .6 MILES ON YOUR RIGHT IS THE COWETA COUNTY JUSTICE CENTER AND THE STATE COURT CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100

TRAVELING FROM SENOIA/GRIFFIN

TRAVEL GA-16 WEST AT THE OF 16 MAKE A RIGHT HAND TURN ONTO US-29 N/GA 14/US-27 ALT/GA-16 JEFFERSON DAVIS MEMORIAL HWY FROM THAT POINT WHILE TRAVELING ON US-29 N YOU WILL TRAVEL APPROXIMATELY 2.6 MILES WHERE YOU WILL COME TO YOUR FIRST TRAFFIC LIGHT*(STREET MARKERS: SPENCE AVE.,) PROCEED STRAIGHT THROUGH THE LIGHT AND ABOUT .6 MILES ON YOUR RIGHT IS THE COWETA COUNTY JUSTICE CENTER. TRAVELING FROM HARALSON

TRAVEL NORTH ON GA-85 UNTIL YOU REACH GA-16, THEN MAKE A LEFT TURN ONTO GA-16 WEST AT THE END OF 16 MAKE A RIGHT TURN ONTO US-29 N/UW-27 ALT/GA-16 JEFFERSON DAVIS MEMORIAL HWY, FROM THAT POINT WHLE TRAVELING ON US-29 N YOU WILL TRAVEL APPROXIMATELY 2.6 MILES WHERE YOU WILL COME TO YOUR FIRST TRAFFIC LIGHT *9(STREET MARKERS: SPENCE AVE.) PROCEED STRAIGHT THROUGH THE LIGHT AND ABOUT .6 MILES ON YOUR RIGHT IS THE COWETA COUNTY JUSTICE CENTER. THE STATE COURT CLERK'S OFFICE IS ON THE FIRST FLOOR AT SUITE 1100
