Law Enforcement Training RFP



- Proposed by Governor Kemp during the 2021 Legislative Session and approved by the legislature.
- Total amount available: \$7.5 million.
- Purpose: to provide funding for law enforcement training grant programs for state and local law enforcement agencies.
- Grant is administered by CJCC and awards will be made on a competitive basis.
- Awards will be made to qualified state and local law enforcement agencies to support training for law enforcement officers in use of force and de-escalation, Crisis Intervention Team (CIT) training, and training to support officer mental health.

CJCC Eligibility



An eligible applicant must meet *all* the following criteria:

- Be state or local law enforcement agency. Applications from local law enforcement agencies must come from the City or County Government.
- Use funding to establish or enhance use of force or de-escalation training, Crisis Intervention Team (CIT) training, and officer mental health support.
- If a local government, City or County must be in compliance with their audit submission requirements to the Georgia Department of Audits and Accounts.
- Must be able to meet fiduciary requirements of the grant (reimbursement).
- No Supplanting.

CJCC What is "Supplanting?"



State grant funds must be used to supplement existing State and/or local funds for program activities and must not <u>supplant</u> (replace) those funds that have been appropriated for the same purpose.

Supplanting: to deliberately reduce State or local funds because of the existence of State grant funds. For example, when local funds are appropriated for a stated purpose and State grant funds are awarded for that same purpose, the local government replaces its local funds with State grant funds, thereby reducing the total amount available for the stated purpose.

Supplementing (adding to) existing resources with State grant funds is ok. **Supplanting** (replacing) those funds with State grant funds is not.

CJCC Program Narrative



- Should be a detailed statement of the work to be undertaken and be responsive to RFP.
- All sections of the Program Narrative must include and address in the order listed in the RFP (Project Description, Needs Statement, Project Goals, Project Activities and Services, Resources Needed).
- Price quotes and/or vendor brochures CANNOT be submitted as a substitute for a program narrative.
- If applying for CIT training or training to support officer mental health, the applicant must describe how the training program will impact use of force and/or de-escalation.

Budget Detailed Worksheet



- Applications must use detailed budget worksheet provided on CJCC's website.
- All portions of budget are subject to review and approval by CJCC.
- Narrative should be included in the provided text box that are shown under each corresponding category.
- Requested budget items must have direct correlation to the grant activities.

CJCC Application Details



- Applications are due Wednesday, December 1, 2021 at 5:00 p.m., EST.
- Award Notification will be made within 30 days of application selection.
- Grant Award Period: January 1, 2022 December 31, 2022.

CJCC Submission Requirements



- Applications must be submitted electronically using the link found within the application provided on CJCC's website: https://cjcc.georgia.gov/grants/funding-opportunities.
- Be sure to submit any letters of support, MOUs, price quotes, vendor brochures, etc. under Other Attachments. This is not required to successfully submit.



- Any application electronically time-stamped after 5:00pm on December 1, 2021.
- Missing and/or incomplete attachments.
- Application from an ineligible applicant.
- Additionally, CJCC may not consider funding any application that fails to comply with any of the stated requirements.
