Violence Against Women Act (VAWA) Grant Program:

1) Prosecuting Attorneys Council (PAC)
Continuation Award Recommendation - \$158,590

Overview of the FFY19 VAWA Grant Program Resource Prosecutor- The purpose of the VAWA funded Domestic Violence & Sexual Assault Resource Prosecutor is to educate prosecutors and law enforcement officers responsible for the investigation and prosecution of domestic violence and sexual assault crimes throughout Georgia.

Georgia Coalition Against Domestic Violence (GCADV)
 Continuation Award Recommendation - \$130,600

Overview of the FFY19 VAWA Grant Program- The VAWA grant programs provides federal funds to foster initiatives that expand and bolster services for victims of domestic violence, sexual assault, stalking and dating violence. It helps fund core domestic violence services across the country, including crisis response, safe housing, advocacy, counseling, legal assistance, safety planning, and comprehensive support. GCADV provides specialized technical assistance to programs identified by CJCC. These are programs that need assistance with training, best practices in programming, and compliance with program standards. The funds would also support the statewide domestic violence crisis hotline.





VOCA Domestic Minor Sex Trafficking Receiving Center

New Award Recommendation: \$1,200,000.00

Overview of the FY20 DMST (Domestic Minor Sex Trafficking) Receiving Center VOCA Competitive RFA:

The Criminal Justice Coordinating Council (CJCC) will partner with the Department of Juvenile Justice (DJJ) and Division of Family and Children Services (DFCS) to help facilitate the development and launch of an immediate triage Receiving Center for Domestic Minor Sex Trafficking (DMST) victims throughout the state of Georgia.

In recent years, the Department of Juvenile Justice (DJJ) conducted a series of juvenile justice reform initiatives that resulted in the closure of a residential treatment facility, which presented an opportunity for a new state-funded program to utilize the space. It was determined that DJJ would receive bond funding to make renovations to the building to serve as an immediate triage option for DMST victims in the form of a Receiving Center.

The DMST Receiving Center seeks to alleviate some of the burdens of human trafficking victims and their non-offending caregivers by eliminating both the need for duplicative storytelling and access to adequate transportation in order to receive the care they deserve. In accordance with the Governor's office priorities to combat the threat of human trafficking in State of Georgia, the Receiving Center uses a compassionate "wraparound" service delivery model to stabilize and begin the healing process for victims of human trafficking. These services include transportation to the facility for an assessment of victims' needs, immediate medical attention, and secure shelter.

The Receiving Center is in Northwest Georgia with a capacity of 20 beds.

Methodology

Three applications were reviewed by a committee comprised of CJCC (3), DFCS (3), and DJJ (3) representatives. Two meetings were convened the week of September 2-6 to discuss the applications. During the first meeting, reviewers viewed supplemental documentation, reviewed state priorities, and budget items. During the second meeting, reviewers shared application scores and comments to finalize the committee's recommendation.

Staff and External Partners Recommendation:

CJCC, DJJ and DFCS recommend awarding Wellspring Living, Inc. in the amount of \$1,200,000.

Wellspring Living, Inc. received highest marks during the application review from all reviewers. Reviewers cited the following as strengths in the application submitted by Wellspring Living, Inc.:

- 1. Licensing Requirements All reviewers cited that Wellspring Living is currently a Residential Child Care Licensed (RCCL) provider. Reviewers cite that though it is possible for other applicants to obtain a RCCL, there is an application process that would likely delay the opening of the DMST Receiving Center. Reviewers from DFCS and DJJ stated that licensing process could take three or more months and a license is not guaranteed. The ability to meet the project goal of providing services to DMST victims by January 1, 2020 was prioritized by the review committee.
- 2. Experience Providing Direct Services Residential The majority of reviewers noted that Wellspring Living, Inc. has a history providing trauma-informed direct services, residential services, and educational services for the population since 2008. Reviewers cite that the organization has contractual agreements with the Office of Provider Management- DFCS and DJJ that allows them to access Room, Board, and Watchful Oversight reimbursements. The ability to access different reliable sources of payment for services was noted as strength to increase the likelihood of sustainability of the program services.
- 3. Evidence of Community Support and Collaboration Reviewers noted that Wellspring Living, Inc. provided several Letters of Support, MOUs, and correspondence with the local community to illustrate collaboration. Reviewers noted that providing evidence of local partner support and/or interest was a priority for the committee. The agency would utilize local partners to leverage their access to funding sources to increase the likelihood of sustainability and to encourage a multidisciplinary/collaborative approach. (i.e. Tanner Behavioral Health Systems, Paulding County School System, Children's Healthcare of Atlanta, Georgia Center for Child Advocacy, etc.)
- 3. Financial Stability Reviewers noted that Wellspring Living has a good ratio between federal/state funding and other/non-federal fund sources. 68% of their current funding being derived private donations, fundraising events, and consignment sales. Wellspring Living over the past five years has been successful in maintaining it funding levels to support its operations and programs; sustaining a healthy balance between grant (restricted) and private (unrestricted) dollars.

- 4. Sustainability Reviewers noted Wellspring Living has approximately \$175,000 of private donation funds in reserve and an established line of credit of approximately \$100,000 which would be able to sustain their current operations for 1-2 months. The reviewers also noted that Wellspring Living has had a history of fundraising success that has supported the steady expansion of programming. Wellspring Living, Inc. has also been awarded discretionary awards from the Office on Violence Against Women.
- * Reviewers cited the concern that the funding available to the selected provider would insufficient to operate the large facility that targets a specialized population with complex needs. DJJ Reviewers provided estimates of \$5-8M to support operations in a facility similar in size. Reviewers were also concerned with the short timeframe for the selected providers to hire staff, train new staff, and create strong local partnerships.

FFY19 Victims of Crime Act Assistance (VOCA) Formula Grant Program

Background

The VOCA Formula Grant Program, created under the 1984 Victims of Crime Act, provides federal funding to support victim assistance and compensation programs, to provide training for diverse professionals who work with victims, to develop projects to enhance victims' rights and services, wand to undertake public education and awareness activities on behalf of crime victims. The Federal Crime Victims' Fund is the source of funding for these programs. Millions of dollars are deposited into the Crime Victims' Fund annually from criminal fines, forfeited bail bonds, penalties, and special assessments collected by U.S. Attorneys' Offices, federal U.S. courts, and the Federal Bureau of Prisons. To date, Crime Victims' Fund dollars have always come from offenders convicted of federal crimes, not from taxpayers.

VOCA Continuation Award Total: \$80,512,427

Staff Recommendations:

- 1) Award the child abuse victim service agencies at current award amounts for a total of \$18,203,534. See TAB A.
- 2) Award the community-based victim service agencies at current award amounts for a total of \$25,215,264. See TAB B.
- 3) Award the domestic violence victim service agencies at current award amounts for a total of \$21,115,141. See TAB C.
- 4) Award the sexual assault victim service agencies at current award amounts for a total of \$9,078,488. See TAB D.

- 5) Award the set-asides (FJC Center Initiative, Reentry Project, CAC Capacity Building, Trauma Recovery Center, Victim Notification System) at current amounts for a total of \$6,900,000. See TAB E.
- 6) Staff Recommendation: Georgia College and State currently receives \$91,966 in VOCA funds to fund a sexual assault advocate position through their Women's Health Center. Due to changes in the federal guidance regarding Title IX and campus advocacy programs, the college has concerns about continuing to provide advocacy to victims of sexual assault through the university. Georgia College and State University has requested that their VOCA award be transferred to The Brighthouse in Milledgeville, a community-based organization. The organizations would create an MOU between the agency and the college to continue advocacy services for student sexual assault victims. The community setting will allow for confidentiality and assistance through Title IX proceedings that the university believes it can no longer provide in accordance with the Title IX guidance. Staff recommends that the award be transferred and would contingent upon an executed MOU between the Brighthouse and Georgia College & State University.

OVC Training and Technical Assistance Grant Program

Continuation Award Total - \$350,000

Overview of the FY18 OVC Discretionary Training and Technical Assistance Grant Program- The goal of this program is to provide training and technical assistance to VOCA victim assistance service providers and others who work with crime victims. Activities funded through this program may include, but are not limited to, the establishment or enhancement of state victim assistance academies (SVAA), statewide training initiatives, crime victim-related conferences, basic training for new programs, or scholarships to attend conferences and/or training for service providers and others who work with victims of crime.

1) **Staff Recommendations:** Award the victim service training agencies at current award amounts for a total of \$350,000. *See TAB F.*

Child Advocacy Center Standards

A standards committee and the Criminal Justice Coordinating Council have worked in partnership to create certification standards for Child Advocacy Centers. These standards ensure quality services are delivered to the state's victims of child abuse. Drafts of the standards were released to service providers for comment and feedback. CJCC staff will conduct annual site visits, now utilizing certification standards for Child Advocacy Center to ensure compliance. The staff recommends that the Council adopt the Certification Standards for Child Advocacy Providers.
