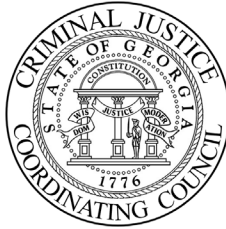

Welcome and Call to Order, *Chairman Ron Freeman*

Chairman Ron Freeman called the meeting to order at 10:32 AM. Ms. Rachel Kilgore called the roll, and a quorum was confirmed. Next, Chairman Freeman called for a review of the minutes of the September 20, 2021 meeting. Assistant Director John Melvin made a motion to approve the minutes; Vice Chairman Sonja Fillingame seconded, and the motion carried.

Victim Assistance Grants Committee, *Ms. Kristy Carter*

FFY21 VAWA Continuation Grant Program Recommendations

Next, Ms. Kristy Carter presented Council members with the recommendations of the Victim Assistance Grants Committee. Regarding the federal fiscal year 2021 Victims of Crime

Act Funding Continuation Grant Program, Ms. Carter directed members' attention to the meeting materials provided, included here as Tab A. She reminded Council members that the Services*Training*Officers*Prosecution (STOP) Violence Against Women Act Grant program has two overarching goals: 1) To foster initiatives that develop and strengthen effective law enforcement, prosecution, adjudication, and offender monitoring strategies to combat violent crimes against women; and 2) To foster initiatives that expand and bolster services for victims of domestic violence, sexual assault, stalking, and dating violence. According to the VAWA Program Guidelines, funding priorities are given to proven strategies that further the common goal of ending domestic and sexual violence. A percentage of each year's formula grant must be allocated to court services (5%), law enforcement (25%), prosecution (25%), victim services, and discretionary (15%). She highlighted the priorities of the program and presented the funding recommendations of the Committee. With no questions or comments, Judge Price motioned to approve the recommendations, totaling \$4,179,610, as detailed in Tab A of these minutes. Commissioner Oliver seconded the motion. It carried unopposed.

FFY21 SASP Continuation Grant Program Recommendations

Secondly, Ms. Carter spoke to the Sexual Assault Services Program's continuation funding. Again, she highlighted the priorities of the grant and directed members to the materials provided. The SASP Formula Grant Program, she shared, supports organizations that provide crisis intervention, advocacy, accompaniment (e.g., accompanying victims to court, medical facilities, police departments, etc.), counseling, and related assistance to: Adult, youth and child victims of sexual assault; family and household members of such victims; and those collaterally affected by the victimization, except for the perpetrator of such victimization (e.g. friends, coworkers, classmates). There were no questions or comments offered from Council members, and Vice Chairman Fillingame made a motion to approve the recommendations, totaling \$508,149, as detailed in Tab B of these minutes. Ms. Bunn seconded the motion, and it carried unanimously.

FY2020 Coronavirus Emergency Supplemental Funding Grant Program

Lastly, Ms. Carter provided updates and recommendations regarding the FY2020 Coronavirus Emergency Grant program. She shared that the purpose of this program is to provide funding to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus. Victim assistance organizations, including domestic violence shelters, domestic violence community-based programs, sexual assault centers, human trafficking programs, child advocacy centers, court appointed special advocates, culturally specific programs, hospital-based violence intervention programs that address gun violence and other violent crimes, elder abuse programs, and prosecution-based victim-witness assistance programs are facing significant challenges as a result of the ongoing pandemic. This comes at a time when victim service delivery is most critical as programs are receiving increased calls for services, increased need for financial assistance for housing, childcare, employment assistance and as courts begin to reopen and address the backlog of cases caused by the COVID-19 pandemic, Ms. Carter added.

Further, she explained that victim service providers must be prepared for the likely increases in victimization rates both during and long after this pandemic. They must address the new challenges and look for innovative solutions based on a community-centered approach. The pandemic created a perfect storm of stressors that correlate with the spikes in levels of crisis calls for assistance providers have experienced in FFY19 and FFY20. The supplemental awards recommended will allow victim service agencies to prevent, prepare and respond to the coronavirus. At this time, the Victim Assistance Division has requested a 12 month no-cost

extension from BJA and is awaiting final approval, and it is the recommendation of the Victim Assistance Grants Committee to award the following (totaling \$252,754):

1. Award \$9,000 to the Crime Victims Advocacy Council, Inc. to meet the increased need of victims due to impacts of the pandemic.
2. Award \$40,000 to the Rabun County Sheriff's Office to assist with hiring a part-time Victim Service Coordinator to assist with the increased number of crime victims and meet the ongoing needs created by the challenges of the ongoing pandemic.
3. Award \$50,000 the District Attorney's Office of Chatham County for assistance for a prosecutor. Ms. Carter also shared that this agency did not apply for VAWA funding in 2020 and approached CJCC to determine if there were any other fund sources to assist with the increased need.
4. Award \$58,272 to Habersham County for a Special Victims Unit investigator. The agency did not apply for VAWA funding in 2020 and approached CJCC to determine if there were any other fund sources to assist with the increased need.
5. Award \$70,000 to the District Attorney's Office of Clayton County for assistance for a prosecutor. The agency did not apply for VAWA funding in 2020 and approached CJCC to determine if there were any other fund sources to assist with the increased need.
6. Award \$25,482 to the Tri-County Protection Agency for a part-time transporter due to the dire need for emergency services. The agency has been at capacity since July 2021 and due to its location has no access to public transportation. The community has lost its cab company and has no access to Uber or Lyft for transportation services due to impacts of the pandemic.

With the conclusion of Ms. Carter's report, Chairman Freeman opened the floor to Council members for any questions or comments regarding the information presented. Hearing none, he called for a vote on the recommendations. Director Skandalakis made a motion to approve and adopt the Committee's recommendations as presented by Ms. Carter. He noted his abstention on the awards to the Chatham County and Clayton County District Attorney's office, due to a potential conflict of interest. Assistant Director Melvin seconded the motion to accept the Committee's recommendations, and it carried unopposed.

Criminal Justice Grants Committee Recommendations, *Mr. Robert Thornton*

Edward Byrne Memorial Justice Assistance Grant Program Funding Recommendations

Mr. Robert Thornton then presented recommendations on behalf of the Criminal Justice Grants Committee. First were recommendations regarding the Edward Byrne Memorial Justice Assistance Grant Program (Byrne JAG), which Chairman Freeman requested be presented and voted on collectively. With no opposition from Council Members, Mr. Thornton shared that at the September 20, 2021 full Council Meeting, the Council approved continuation allocations and awards for all drug task forces and state agencies that received Byrne JAG Program awards. Allocations were based on recipients' 2021 funding levels, and the Council authorized CJCC staff to make awards to all applicants up to the amounts that were allocated. CJCC issued a call for Byrne JAG continuation applications with a deadline of October 22, 2021. One local and one state applicant requested additional funds. Haralson County (Haralson-Paulding Drug Task Force) requested increased funding but did not provide justification related to increased coverage areas or other qualifying changes that have been previously used to grant additional funding. Additionally, the Sexual Offender Registration Review Board (SORRB) requested additional personnel funding for several programmatic objectives. At this time, Mr. Thornton shared, the

Criminal Justice Grants Committee recommends approving continuation awards to Haralson County (Haralson-Paulding Drug Task Force) and the Sexual Offender Registration Review Board but denying the increase requested by Haralson County. They also recommended tabling the increase requested by SORRB while staff works with the Governor's Office to determine priorities for the state portion of Byrne JAG funding.

Next, Mr. Thornton shared with Council members that the Byrne JAG Program requires each state to develop a comprehensive statewide 5-year strategic plan. To work towards this plan, CJCC recommends creating a criminal justice strategic planning position which, in addition to meeting the requirements of Byrne JAG, would better position CJCC to administer current funding and prepare us to administer and allocate any new funds received in the future. As criminal justice planning is an allowable programmatic activity under the Byrne JAG Program, this position would be funded with Byrne JAG programmatic funds. Funds would also be allocated to the Statistical Analysis Center to support the strategic planning function with its data needs. At this time, the Criminal Justice Grants Committee recommends approving the allocation of \$100,000 to the CJCC to support criminal justice strategic planning.

Residential Substance Abuse Treatment for State Prisoners (RSAT) Grant Program

The RSAT Formula Grant Program, Mr. Thornton reported, assists states and units of local government in developing and implementing residential substance abuse treatment programs within state and local correctional and detention facilities in which prisoners are incarcerated for a period of time sufficient to permit substance abuse treatment. Each grantee is required to provide a 25% match on the approved grant award. In an effort to more effectively manage RSAT grant funding, Mr. Thornton reported, staff sought approval from the Committee to move all current grantees to a January through December grant cycle, beginning January 2022. Given that the two state and four local subgrantees have differing grant cycles, staff will calculate each subgrantee's balance at 12/31/2021 and process awards to ensure each subgrantee has access to RSAT funds for the 2022 calendar year that are equal to their most recent annual continuation award. In addition, once award amounts are finalized for calendar year 2022, staff will develop an allocation strategy that may include releasing another competitive RFP.

The Criminal Justice Grants Committee recommends moving all RSAT awards to a calendar year grant cycle and awarding funding to each subgrantee that is equal to each subgrantee's most recent annual award less the balance of their current award at 12/31/2021.

Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program

Next, Mr. Thornton shared an update regarding the FY20 Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP). The COSSAP naloxone initiative is purposed to provide funding to cover the cost of naloxone kits as well as ongoing law enforcement training in naloxone administration, Overdose Detection Mapping Application Program implementation standards that commit to reporting, and best practices for engaging with people suffering from opioid addiction. On September 7, 2021, CJCC released a competitive Request for Proposals. Applications for the opportunity were accepted through October 8, 2021. Forty-seven applications were received from throughout the state requesting various forms of assistance. Based on the information provided in the applications, staff reviewed and recommended funding forty-five of the entities that requested funding within the parameters of the grant conditions. Staff recommended denying two requests: one was for funding not related to first responders and another receives funding through a Juvenile Justice Opioid Initiative. All entities

requested Narcan, but the majority will not require training. Those in need of training will receive it through a CJCC-GPSTC grant partnership. It is the Criminal Justice Grants Committee's recommendation to make 2020 COSSAP awards totaling \$473,332 based on the recommendations included in Tab C.

Department of Community Affairs – Accountability Courts Housing Grant

Although not an action item, Mr. Thornton gave members of the Council a brief update regarding the Accountability Courts Housing Grant. CJCC has partnered with The Council of Accountability Court Judges (CACJ) and the Department of Community Affairs (DCA) to provide housing assistance through the Emergency Solutions Grant-CARES (ESG-CV) program. Funds will be made available between January 1, 2022 and September 30, 2022. CJCC/CACJ released a Request for Applications and received 15 responses. The requested grant funding was reviewed and approved by the Funding Committee of CACJ. Mr. Thornton referred members to the list of grant awards included in their meeting materials, and shared that CJCC, CACJ and DCA are currently working to execute these awards.

Juvenile Justice Incentive Grant Program

Lastly, Mr. Thornton presented a brief update and recommendation regarding the Juvenile Justice Incentive Grant. This grant program provides evidence-based programming in the community for youth who are at a moderate to high risk to recidivate. As of November 22, 2021, he reported, grantees had expended a total of \$1,124,002. Grantees have expressed how the pandemic has affected the expenditures due to the number of program referrals. This was result of less youth being petitioned, court cases not being heard at the same pace, technology issues, and local staff turnover. After the end of quarter 2 (December 30, 2021), staff will provide members with the updated de-obligation funding amount. At this time, it is the recommendation of the Criminal Justice Grants Committee to allow current recipient counties to serve additional delinquently adjudicated youth by permitting counties to serve youth who have scored a 0 to 1 on the PDRA, if these youth are appropriate for programming. Any courts planning to service additional youth by utilizing this allowance will be required to submit a special request form. In addition, this one-time allowance would expire at the end of FY2022 unless it is extended by the Council.

At the conclusion of Mr. Thornton's report, Chairman Freeman opened the floor for any comments or questions regarding the report and recommendations. Vice Chairman Fillingame commented on the Strategic Planning Position that was being recommended and voiced that she believed it to be a good utilization of funding. She added that this position would greatly benefit the agency and was much needed. Mr. Thornton shared that this position had been modeled after the Victim Assistance Division's Project Coordinator position. With no further comments and no questions, Chairman Freeman called for a motion. Vice Chairman Fillingame moved to accept the recommendations from the Criminal Justice Grants Committee as presented by Mr. Thornton. Ms. Jacqueline Bunn seconded the motion. Chairman Freeman and Mr. Brian DiNapoli both abstained from voting on the award recommendations for their respective associations due to a potential conflict of interest. Chairman Freeman abstained regarding the award to Forsyth County, and Mr. DiNapoli abstained regarding the award to the Department of Community Affairs. The motion carried unopposed.

Nominating Committee Recommendations, Deputy Director Steven Hatfield

Deputy Director Steven Hatfield then presented recommendations on behalf of the Nominating Committee. He shared that, as required by O.C.G.A. § 35-6A-4, the Nominating Committee (Sheriff Ron Freeman [chair], Ms. Jacqueline Bunn, Ms. Sonja Fillingame, Mr. Joe Hood, and Commissioner Tyrone Oliver) met on Thursday, November 4, 2021, to elect a slate of officers to stand for election at this December 6, 2021 full Council meeting. At that time, the Committee made the following recommendations for the Council's consideration: Regarding the position of Chairman of the Council, the Committee recommended Ms. Sonja Fillingame to succeed current Chair, Sheriff Ron Freeman. Chairman Freeman opened the floor for any additional recommendations for consideration by Council members. Hearing none, he asked for a vote. Assistant Director Melvin motioned to accept the Committee's recommendation and appoint Ms. Sonja Fillingame to the position of 2022 Council Chairman. Ms. Bunn seconded the motion, and it carried unopposed.

Regarding the position of Vice Chairman of the Council, Deputy Director Hatfield shared, the Committee recommended Mr. Joe Hood to succeed current Vice Chair Sonja Fillingame. Again, Chairman Freeman opened the floor for any additional recommendations for consideration by Council members. Hearing none, he asked for a vote. Mr. DiNapoli made a motion to accept the Committee's recommendation and appoint Mr. Hood to the position of 2022 Council Vice Chairman. Ms. Bunn seconded, and the motion carried.


Old/New Business



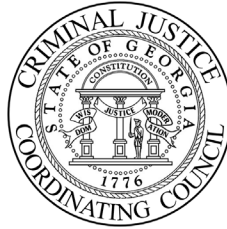

Tab C: Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program

The purpose of the FY20 Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP) naloxone initiative is to provide funding to cover the cost of naloxone kits as well as ongoing law enforcement training in naloxone administration, Overdose Detection Mapping Application Program (ODMAP) implementation standards that commit to reporting, and best practices for engaging with people suffering from opioid addiction.

The Criminal Justice Unit released a competitive Request for Proposal (RFP) on September 7, 2021. Applications for the opportunity were accepted through October 8, 2021. The mission was to provide funding for naloxone kits, training, and assistance with implementing Overdose Detection and Mapping Application Program (ODMAP) to twenty-one jurisdictions around the state. The team received forty-seven applications from agencies statewide requesting various forms of assistance. Based on the information provided in the applications, the team reviewed the applications and provided recommendations. Based on the applications evaluated, the unit hopes to assist forty-five of the entities that have requested aid within the parameters of the grant conditions.
