#### **Domestic Violence- State Funds**

#### Continuation Awards Recommended: \$11,615,854

#### New Awards Recommended: \$150,000

#### Overview of the FY20 Domestic Violence Grant Program:

The purpose of the DV State funds is to provide intervention services, awareness, and education to Georgia's citizens on domestic violence prevention strategies that will change the attitudes of communities. Core intervention services include: safe, confidential shelter staffed 24 hours a day, 7 days a week; 24-hour crisis line answered by Committee; service planning/case management; safety planning; structured children's activities; individual and group counseling, peer support groups and referral to such services to include adults, teens, and children exposed; legal advocacy; medical advocacy; social service advocacy; financial advocacy/means of support; household establishment services; transportation access; follow-up; TANF assessments; parenting support/education; non-residential support services; and community outreach and awareness. Committee recommends continuing funding the 46 programs at FY20 award amounts. The General Assembly increased FY19 funding levels by \$150,000.00 for domestic violence shelter programs. Committee recommends dividing the increase equally among two

- 1) *Committee Recommendation:* Award the 46 programs at their current award amounts in the amount of \$11,615,854. *See TAB A.*
- 2) **Committee Recommendation:** Award two new domestic violence shelter programs, Colquitt County Serenity House Project, Inc. and the Center for Pan Asian Community Services, Inc. awards in the amount of **\$75,000** per agency. *See TAB A*.

#### Sexual Assault- State Funds

#### Continuation Awards Recommended: \$1,076,526

#### New Awards Recommended: \$240,000

#### Overview of the FY20 Sexual Assault Grant Program:

The purpose of the SA State funds is to provide primary, secondary and tertiary services to victims of sexual assault and their families, as well as provide outreach and awareness services to the larger community. Core intervention services include, advocacy/crisis intervention; emergency financial assistance; follow-up contract; follow-up exams; forensic medical examinations; individual/family therapy; legal advocacy; medical accompaniment; support groups; and assistance with victims' compensation. Committee recommends continuing funding the 22 programs at FY19 award amounts. The General Assembly increased FY19 funding levels by \$240,000.00 for sexual assault programs. Committee recommends awarding six certified sexual assault agencies that perform forensic medical services on-site.

- 1) *Committee Recommendation:* Award the 22 programs at their current award amounts in the amount of \$1,076,526. *See TAB B.*
- 2) *Committee Recommendation:* Award six new certified sexual assault agencies that perform forensic medical services on-site awards in the amount of \$40,000 per agency. *See TAB B.*

#### Sexual Assault-Preventive Health Block Grant (PHBG)

#### Recommended: \$200,970

**Overview of the FY20 Preventive Health Block Grant:** The purpose of the FY20 Preventive Health Block Grant is to provide awareness and education to Georgia's citizens on sexual assault prevention strategies that will change the attitudes of communities regarding nonconsensual sex and violence. Education and awareness activities will be accomplished through the provision of trainings, presentations, technical assistance, community outreach, and collaboration. 1) *Committee Recommendations:* Award the 22 sexual assault centers at current award amounts (\$9,135 per subgrant) for a total of **\$200,970**. *See TAB B.* 

#### Domestic Violence-Family Violence Prevention and Services Act (FVPSA)-FFY19

#### Recommended: \$2,936,641

**Overview of the Formula Family Violence Prevention & Services Act Domestic Violence Program:** The FVPSA Domestic Violence grant provides federal funds to support emergency shelters and supportive services for victims of domestic violence and their dependents. It helps fund core domestic violence services across the country, including crisis response, safe housing, advocacy, counseling, legal assistance, safety planning, and comprehensive support. The purpose of these funds is to address one or more of the following priority areas: 1) increased entry for underserved populations to access services; 2) teen dating violence; 3) children exposed to violence; and 4) access to mental health and substance abuse services.

1) *Committee Recommendation:* Award the 46 programs at their current award amounts in the total amount of \$1,578,686.00. \**See TAB C.* 

**Overview of the FFY19 Family Violence Prevention & Services Act Domestic Violence Mini-Grant Program-** The purpose of the FVPSA Domestic Violence Mini-Grant Program is to: 1) increase public awareness about, and primary and secondary prevention of, family violence, domestic violence, and dating violence; and 2) provide access to supportive services for victims of family violence, domestic violence, or dating violence and their dependents; and 3) provide specialized services for children exposed to family violence, domestic violence, or dating violence, underserved populations, and victims who are members of racial and ethnic minority populations. The subawards address non-residential, supportive services for domestic violence organizations that serve one or more of the identified special populations: the elderly, teenagers/adolescents; victims with mental health and/or substance abuse issues; victims located in rural areas; and victims who are members of racial and ethnic minority populations.

#### Committee Recommendation:

1) Award the 30 programs at their current award amounts in the total amount of \$1,357,955.00. \*See TAB C.

#### Commercial Sexual Exploitation of Children-Temporary Assistance for Needy Families (TANF)

#### Recommended: \$857,750

**Overview of the FY20 TANF Commercial Sexual Exploitation of Children Grant Program:** TANF funding has been identified to promote the development of a system of care service delivery to meet the needs of this special population of CSEC victims. The purposes of TANF are to: 1) provide assistance to needy families so that children can be cared for in their homes; 2) end the

dependency of needy parents on government benefits by promoting job preparation, work, and marriage; 3) prevent and reduce the incidence of out-of-wedlock pregnancies; and 4) encourage the formation and maintenance of two-parent families. TANF funds are used to coordinate a statewide response to CSEC with the assistance of partnering agencies throughout the state. These funds also assist with CSEC/DMST trainings, research/evaluation and the coordination of the Georgia Statewide Task Force. Committee recommends continuing funding programs at their current award amounts.

1) *Committee Recommendation:* Continue current subgrants and projects in the amount of \$857,750. *See TAB D.*
