

Explanation of Affiliate Level Membership with the Criminal Justice Coordinating Council's Statewide Human Trafficking Task Force

Affiliate level membership with the Criminal Justice Coordinating Council's Statewide Human Trafficking Task Force is explained as: Public, private, civic, faith-based and other organizations that are involved in initiatives, programs, activities and the like that are affiliated with impacting some aspect of the human trafficking problem, and that elect to have their efforts and impact documented as a viable part of the State's work to eradicate human trafficking in Georgia. These entities elect to not have a direct involvement with specific CJCC-Human Trafficking Task Force projects, though their efforts are coordinated with or may in fact support, reinforce, or otherwise contribute to the success of such projects. Representatives of these organizations may or may not attend Task Force Work Group meetings. When they do so, it is strictly in role supportive of Work Group projects. Affiliate level members have as much or as little involvement with the Statewide Human Trafficking Task Force workgroups as they choose. There are no time requirements or restrictions that Affiliate level members much adhere to in order to remain an Affiliate level member. Affiliate level members participate in the quarterly CJCC Statewide Human Trafficking Task Force meetings and offer their support and coordinated efforts to workgroup projects as needed or requested.

Affiliate level members with the CJCC Statewide Human Trafficking Task Force initially complete an Affiliate level application and sign a statement of request for Affiliate level membership. The purpose of requesting membership is to provide individuals and organizations with a formal, fair, and responsive process for becoming a member of the CJCC-Statewide Human Trafficking Task Force. Affiliate level members are decided on by the Criminal Justice Coordinating Council.

Instructions for Applying for Affiliate Level Membership with the Criminal Justice Coordinating Council's Statewide Human Trafficking Task Force

To be considered for Affiliate Level Membership with the Criminal Justice Coordinating Council's Statewide Human Trafficking Task Force, applicants must completely fill out the Official Statement of Request for Affiliate Level Membership on the Criminal Justice Coordinating Council's Statewide Human Trafficking Task Force. All application packets must be completed and signed by the Director/CEO of the organization. Any received application packets that are incomplete and/or not signed by the Director/CEO of the organization will not be considered for Affiliate Level Membership on the Statewide Human Trafficking Task Force.

Open enrollment for 2015 Task Force membership is from Monday, November 3 – Monday December 15, 2014.
