#### **Project Description**

Every year, Refugee Family Services (RFS) serves approximately 2,500 refugee/immigrant women and children in the metro-Atlanta area. RFS provides critical human services, youth programs, health services, education programs, and domestic violence prevention programs. This work furthers RFS's mission to support the efforts of refugee women and children to achieve self-sufficiency in the United States by providing education and economic opportunity. RFS provides culturally and linguistically appropriate services through the Community and Youth Center, located in unincorporated Stone Mountain, Georgia (metropolitan Atlanta). All RFS programs focus on helping refugee women achieve self-sufficiency, and nowhere is this mission more clear or critical than in the Refugee Family Violence Prevention Project (RFVPP), where achieving self-sufficiency is often a matter of life or death for refugee women facing violent situations. Refugee Family Services, formerly Newcomers' Network, is an outgrowth of Save the Children/Child Care Support Center, Atlanta. Originally, the program provided

childcare training to refugee women in the metro Atlanta area, and then grew into the Refugee Program, adding many refugee services. Newcomers' Network, Inc. was incorporated in 1996 to operate the refugee program as a stand-alone entity and became a fully independent 501(c)(3) non-profit organization on October 1, 1997. The present name, Refugee Family Services, went into effect in June of 2002. Since first receiving CJCC funding in 1999, the RFVPP has served more than 1,000 refugee/immigrant victims of domestic violence and approximately 2,000 secondary (children) victims. Also since 1999, more than 100 women have been placed safely in shelters, and approximately 200 women have exercised their legal option to obtain a TPO. The RFVPP has also helped hundreds to build a self-sufficient future for themselves and their families by obtaining driver's licenses, preparing for employment, and becoming active in their children's schools.

## **Project Description**

Established in 1989 and primarily serving Forsyth and North Fulton counties, Forsyth County Family Haven, a domestic violence agency, provides immediate crisis intervention. The goal is to promote, support and equip potential victims and survivors with the knowledge and skills necessary to progress beyond victimization. Those the agency serves have access to the following programs and services: 24 hour hotline offers immediate crisis assistance seven days a week by: 1. Being the first step toward the healing process for survivors; 2. Listening, being compassionate, sensitive and supportive while providing information on programs, services and resources available to survivors; and 3. Answering questions as needed.

Emergency Shelter (27 beds) is offered up to 90 days for survivors and their children in a confidential setting. This is Tier I of housing services. While in shelter, survivors receive emotional support, food, and clothing, advocacy for medical, legal and financial resources, information and referrals. Transitional Housing (3 units) is offered up to one year for survivors and their children in a confidential setting. This is an expansion of Tier I to include one year of free housing while assisting head of households in developing knowledge, skills and abilities to obtain a job, increase income opportunities, and manage finances. Shelter Advocates provide advocacy to victims by offering safety planning, supportive services, referrals and assistance with access to community resources. Case Managers assess, plan, refer and monitor survivors to help them become self-sufficient in a life free of violence.

Legal Advocates assist survivors with questions concerning their rights as a victim of a crime, filing and completing a Temporary Protective Order (TPO) and accompaniment to related court proceedings. Counseling Services are provided to clients Monday through Friday free of charge by Licensed Professional Counselors (LPC) individually and in group settings. Community Outreach works to enact social change and prevent domestic violence by engaging the entire community in conversation and by encouraging people of all genders, ages and backgrounds to speak out against violence. Aftercare helps survivors learn about resources in their new community and advocates on their behalf so they stay in permanent housing and out of abusive relationships.

### **Project Description**

Atlanta Victim Assistance, Inc. (AVA) ensures that families and survivors of domestic violence, child abuse/neglect, sexual assault and the family survivors of a homicide victim have access to comprehensive services that ease their transition from victim to victor. AVA's main domestic violence priorities are to reinforce victim safety and security and end each instance of violence and abuse. Recognizing that victims may not appreciate the extent to which they are in danger, AVA has developed a strategy that moves victims, a bit more gradually, toward safety. The advocates encourage abused women to seek legal remedies such as bond orders as an 'on ramp' toward the twelve months Temporary protective Order (TPO). Cases that are heard in the City of Atlanta Municipal Court may be

eligible for Special Conditions Bond Orders or TPO as recourse to aid in the protection from the immediate violence in homes throughout the city of Atlanta. Atlanta Victim Assistance continues sit at the nexus of the network of law enforcement, legal and nonprofit groups to collectively address domestic violence.

GLSP's clients have income at or below 200% of the federal poverty guidelines. The agency serves 154 counties surrounding the metro-Atlanta area. Parts of GLSP's service region suffer from chronic poverty, and some regions have no practicing lawyers. GLSP handles only civil legal problems that affect a family's basic need for food, shelter, healthcare, safety and stability. The agency sets priorities for the types of cases that it handles based on information from community needs assessments gathered by 11 field offices. GLSP's priorities are supporting families,

preserving homes, maintaining economic stability, achieving safety, stability, and healthcare, serving populations with special vulnerabilities, and improving the delivery of legal services.

#### **Project Description**

FAITH in Rabun County, Inc, FAITH, was initially established in 1993 in a grass roots effort to assist victims of domestic violence. In 1994 FAITH formed a Board of Directors, applied for incorporation and nonprofit status, started a hot line and hired its first director. In 1995 the FAITH Thrift Store opened and in 1996 FAITH purchased and renovated the first shelter. The need for services increased and in 1998 the sexual assault program was incorporated to assist sexual assault victims and adults molested as children. As the need grew to include children, efforts and collaborations resulted in the opening of FAITH's child advocacy center, The Power House for Kids. At present FAITH has recently purchased and renovated a historic building in Rabun County that serves as the office as well as a shelter. FAITH's mission is to provide free and confidential services which include but are not limited to: a crisis line manned 365 days a year, 24 hours a day, crisis intervention and crisis counseling, educating victims of the legal process and their rights, court accompaniment, protective orders, stalking orders, follow up, information and referrals, hospital accompaniment, comfort kits, counseling and support groups, peer support, job resumes, emergency food and clothing, transportation, financial assistance, forensic interviews, peer support and parenting, follow up with interrelated agencies and transitioning assistance. To further carry out FAITH's mission, the agency also works to create awareness and educate the community to prevent further victimization.

S.A.F.E. is a private, non-profit organization serving Union and Towns counties since 1989. SAFE's mission is to provide support, advocacy and emergency shelter to victims of domestic abuse, child abuse and sexual abuse, regardless of gender, and to heighten community awareness of such abuse in Union and Towns counties. The agency is unique in its provision of comprehensive services to Union and Towns counties to include domestic violence intervention and emergency shelter, sexual abuse victim services, child abuse/maltreatment services, supervised child visitation and family support services. Medical response/accompaniment is provided for victims of abuse. This assessment and safety plan will include providing victims with information regarding their rights and assisting them with accessing legal remedies such as protective orders, law enforcement reports and court interventions.

#### **Project Description**

Satilla Advocacy Services (SAS), operates under the umbrella of Satilla Regional Medical Center, the local hospital in Waycross, Georgia. Satilla Advocacy Services was developed in 1999 in response to the need to provide services to victims of sexual assault that were seen in the Emergency Department of the hospital. In 2001, the Child Advocacy Center component was added in answer to the historical statistics of child victims in the community. Since its inception, SAS has served over 3000 new clients, with approximately 70% of those being 17 years of age or younger. The agency now serves the six counties of the Waycross Judicial Circuit: Ware, Pierce, Brantley, Bacon, Coffee and Charlton. Almost twenty percent of this region's population is living below the poverty level. The region's per capita income is \$14,012 compared to the state of Georgia's per capita income of \$21,254. The rural nature of the service area creates a barrier to access to services because of nonexistent services and a lack of public transportation.

Even with these barriers, SAS provides the following services to all victims of violent crimes: a sexual assault response team with a 30 minute response time for crisis intervention in the emergency room, a multi-disciplinary team approach for victims under 19 years of age, two fully equipped interview rooms utilized by law enforcement and by the Department of Family and Children's Services for recording forensic interviews with child victims as well as adult victims with disabilities. Other services provided include the use of volunteer advocates, coordinating follow-up medical appointments for victims, a legal advocate for court appearances, therapy, crisis intervention, and a 24-hour crisis line.

The mission of Satilla Advocacy Services is to promote community awareness of sexual assault by providing education and to empower community organizations and agencies to build an organized system that provides supportive services for all victims of sexual assault and child victims of suspected sexual and/or physical abuse. Through community partnerships, sound fiscal management and dedicated personnel, Satilla Advocacy Services is making a difference.

### **Project Description**

In 1986, District Attorney Jack Partain, as an extension of the District Attorney's Office established the Victim/Witness Assistance Program. One of his goals was to provide an organized and compassionate system for victims of crime who were often neglected and ignored by the system designed to protect them. It continues to be our mission and as unmet needs of crime victims in our community have surfaced, the District Attorney's Office and Victim Services Office have worked alongside a coalition of community, business, and agency service providers to develop and provide for those underserved and often ignored victims. VOCA funds are used to provide on-site therapy to child victims of child physical and sexual abuse. In 2009, a S.A.R.T. was formed, a Sexual Assault Protocol Committee established, approval by the GreenHouse Board of Directors to expand the GreenHouse to include as part of its mission the establishment of a SAC as part of its agency, and preliminary plans to build a new facility with two floors to house both the SAC and CAC. In addition, the community hospital has partnered with the DA's office, VWAP office, GreenHouse, and DA DV Unit to provide a private examination room and procedure for sexual assault exams, and has trained 3 SANE's to be available to victims of sexual assault. In 2010 A SAC Advocate was added to work with the S.A.R.T. The S.A.R.T. Protocol is completed and in the process of being signed. A copy of approved Protocl is attached to this application.
