# Why Report To CJCC?

- **Required by the Bureau of Justice Assistance (BJA)**
- **End results:**
  - **Assess project performance**
  - **Provide appropriate technical assistance**
  - **Justify continued funding**



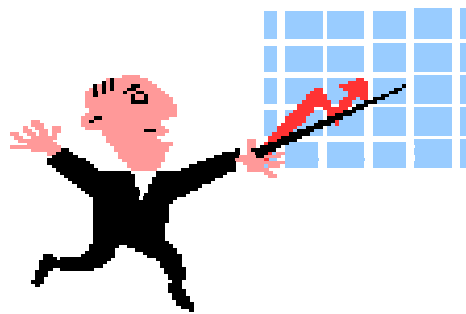
# Programmatic Reports

- **Timeline for reporting grant activity:**
  - **Reporting period is January 1<sup>st</sup> – December 31<sup>st</sup>:**
    - **New Measures April 1<sup>st</sup> – June 30<sup>th</sup> due July 10<sup>th</sup>**
    - **July 1<sup>st</sup>-September 30<sup>th</sup> due October 10<sup>th</sup>**
    - **October 1<sup>st</sup> –December 31<sup>st</sup> due January 10<sup>th</sup>**
    - **January 1<sup>st</sup> –March 31<sup>st</sup> due April 10<sup>th</sup>**





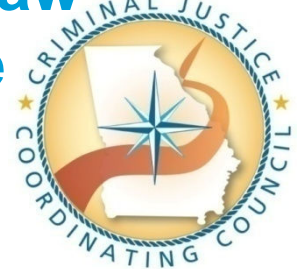
The BJA Training and Technical Assistance Tool helps BJA grantees do the following:

- Report on activity related to these events



# Purpose Areas

- **Law Enforcement Programs**
  - Include drug task forces, gang task forces, and other policing efforts
- **Prosecution and Court Programs**
  - Programs which improve response to violent crime through prosecution and adjudication of offenders
- **Prevention and Education Programs**
  - Projects which address safety concerns of law enforcement, emergency personnel, and the public



# Purpose Areas (cont'd)

- **Corrections and Community Corrections Programs**
  - **Include residential and aftercare programs for offenders**
- **Drug Treatment Programs**
  - **Include drug courts, substance abuse counselors, and other services aimed at substance-abusing offenders**





# Purpose Areas (cont'd)

- **Planning, Evaluation, and Technology Improvement Programs**
  - **Projects aimed at updating computer equipment, records management systems, or other components of the criminal justice system**
- **Crime Victim and Witness Programs**
  - **Include victim advocacy, victim notification, and witness programs**
